### Simplify Email Management

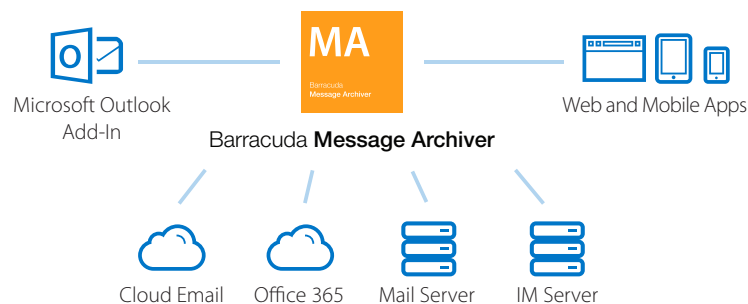
